Item 4: Chairman's report

i) AGM 2021:

The Chairman suggested a decision needs to be made whether, due to current Government Covid-19 restrictions, which are due to possibly run until Easter 2021 (4th April), that we now decide to cancel going to RAF Valley & plan for an online AGM. **This was agreed unanimously**

iv) Replacement Treasurer:

Mazza, our present Treasurer, has confirmed to me that she felt it better to stand down from the Committee at the next AGM. Since we rarely get inundated with volunteers for positions on the Committee I have been looking for a suitable replacement. To this end, I have found a retired policeman (Richard Wiltshire) who is willing to take up the challenge from the AGM or from year start, **whichever the Committee decides**. Richard is UK based, which will make it easier to transfer access to the branch accounts, which does take time. Obviously his position would need to be confirmed at the AGM.

Mazza **could** still run through to year end 31/12 & present the AGM report. The branch "might" have to find a new suitable auditor for the accounts in 2022.
